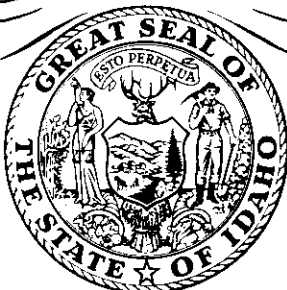

ARTICLES OF INCORPORATION  
OF  
VALLEY VIEW LAND COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, THE UNDERSIGNED, NATURAL PERSONS OF THE AGE OF 21 YEARS OR MORE, CITIZENS OF THE UNITED STATES, ACTING AS INCORPORATORS UNDER THE LAWS OF THE STATE OF IDAHO, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION FOR VALLEY VIEW LAND COMPANY, INC.

I. NAME

THE NAME OF THIS CORPORATION IS TO BE VALLEY VIEW LAND COMPANY, INC.

II. PURPOSES

THE PURPOSES FOR WHICH VALLEY VIEW LAND COMPANY, INC., IS INCORPORATED ARE AS FOLLOWS:

1. TO GENERALLY ENGAGE IN, DO AND PERFORM ANY ENTERPRISE, ACT OR VOCATION THAT A NATURAL PERSON MIGHT OR COULD DO OR PERFORM.
2. TO ENGAGE IN BUYING, SELLING, SUBDIVIDING, AND IMPROVING LANDS AND TENEMENTS; THE LOANING OF MONEY FOR ITSELF AND AS AGENT FOR OTHERS, UPON MORTGAGES OR OTHER SECURITIES, AND THE PURCHASING AND SELLING OF LANDS, AND OF MONEY OBLIGATIONS SECURED UPON REAL OR PERSONAL PROPERTY; THE BUYING, WORKING, SELLING, AND DEALING IN MINERAL LANDS AND OTHER LANDS; THE ACQUIRING, HOLDING, SELLING, HYPOTHECATING, ASSIGNING, TRANSFERRING, AND CONVEYING OF ITS OWN OBLIGATIONS, OR THE OBLIGATIONS OF ANY PERSONS OR OTHER CORPORATION, AND COLLECTION, FORECLOSING, COMPOUNDING, COMPROMISING, RELEASING, SATISFYING, AND DISCHARGING THE SAME OF RECORD; THE BUYING, OWNING,

AND IMPROVING OF REAL ESTATE BY ERECTING BUILDINGS AND OTHER STRUCTURES THEREON AND LEASING AND CULTIVATING THE SAME; THE BORROWING OF MONEY AND EXECUTING MORTGAGES OR DEEDS OF TRUST UPON REAL ESTATE OR PERSONAL PROPERTY AS SECURITY THEREFOR; THE BORROWING OF MONEY AND THE EXECUTING AND ISSUING OF PROMISSORY NOTES, BILLS OF EXCHANGE, BONDS, DEBENTURES, OR OTHER NEGOTIABLE OR TRANSFERABLE INSTRUMENTS; THE DOING OF ANY OR ALL OF SAID ACTS EITHER ON ITS OWN BEHALF OR AS AGENT FOR OTHERS; AND THE DOING OF ANY AND ALL ACTS NECESSARY FOR THE CARRYING OUT OF THE POWERS ABOVE ENUMERATED.

3. TO PURCHASE, HOLD, SELL, TRANSFER SHARES OF ITS OWN CAPITAL STOCK PROVIDED IT SHALL NOT USE ITS FUNDS OR PROPERTY FOR THE PURCHASE OF SUCH SHARES WHEN SUCH USE WOULD CAUSE ANY IMPAIRMENT OF ITS CAPITAL STOCK.

### III. DURATION

THE PERIOD OF DURATION OF VALLEY VIEW LAND COMPANY, INC. SHALL BE PERPETUAL.

### IV. LOCATION AND POST OFFICE ADDRESS OF REGISTERED OFFICE IN THIS STATE

THE LOCATION AND POST OFFICE ADDRESS OF THE REGISTERED OFFICE OF VALLEY VIEW LAND COMPANY, INC., AND THE PLACE OF ITS GENERAL BUSINESS AND ITS PRINCIPAL OFFICE SHALL BE BLAKE & GIVENS, 1219 IDAHO STREET, LEWISTON, IDAHO. BRANCH PLACES OF BUSINESS AND OFFICES FOR CARRYING ON THE BUSINESS OF THE CORPORATION MAY BE ESTABLISHED AT SUCH OTHER PLACES AS THE BOARD OF DIRECTORS MAY DEEM ADVISABLE AND THE BUSINESS OF SAID CORPORATION MAY BE CARRIED ON IN ANY OTHER STATE, STATES, COUNTRY OR COUNTRIES. 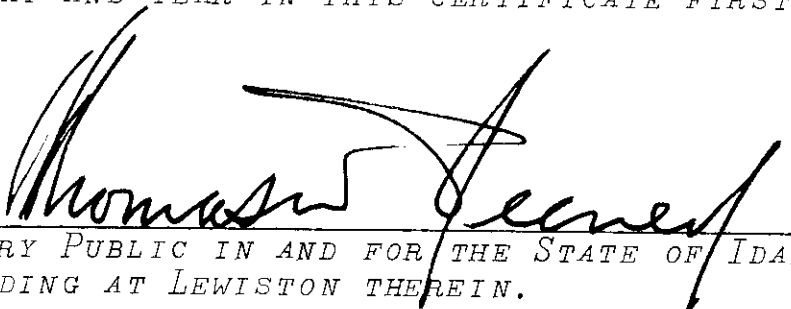
