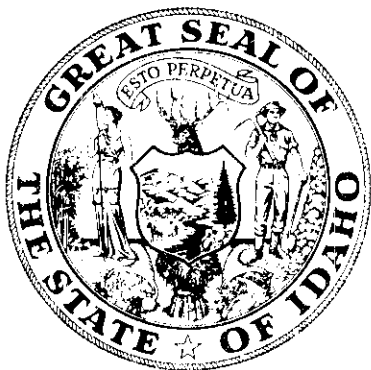

The undersigned officers, acting under the authority of the shareholders of a corporation under the Idaho Business Corporation Act, adopt the following resolution to restate the articles of incorporation.

Resolved, by a unanimous vote of the shareholders, that the corporation restate its articles of incorporation. The operative provisions of the articles of incorporation are as follows:

1. The name of the corporation is STARPOINT INC..
2. The period of its duration is perpetual.
3. The purpose for which the corporation is organized is the transaction of any and all business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. The number of shares which the corporation shall have authority to issue is 90,667 shares of a single class, with no par value.
5. Provisions denying preemptive rights are: None.
6. Provisions for the regulation of the internal affairs of the corporation are: None.
7. The address of the registered office of the corporation is 1342 N. Liberty, Boise, Idaho 83704; and the name of its registered agent is Wesley E. Corp.
