ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be WEST PAINT AND SPRAY SUPPLY, INC.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is formed to carry out any lawful purpose and shall have all the powers allowed by the laws of the State of Idaho.

ARTICLE IV

The capital stock of this corporation shall be in the amount of \$250,000.00 divided into 25,000 shares of non-assessable common stock of the par value of \$10.00 per share.

The management of this corporation shall be vested in a board of not less than one director and a maximum number as may be fixed by the Bylaws. 
ARTICLE VIII

The private property of the stockholders of this corporation shall not be subject to the payment of the corporate debts in any amount or to any extent whatever.

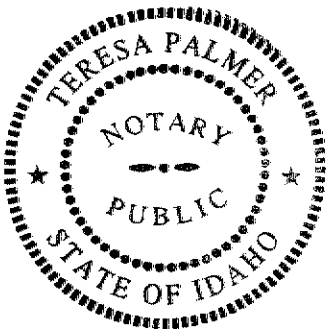
