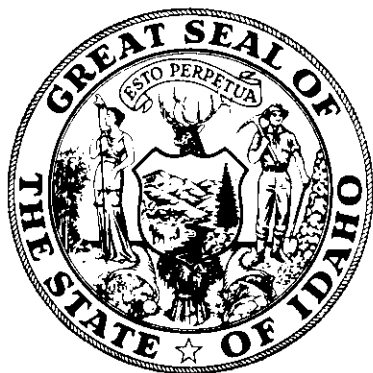

ARTICLES OF INCORPORATION

OF

SOUTHERN IDAHO FREIGHTLINES, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are natural persons of full age, citizens of the United States of America and residents of the State of Idaho, have this day voluntarily associated ourselves together, and do hereby and by these Articles of Incorporation unite and associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho for the purposes hereinafter stated.

I.

The name of the corporation shall be SOUTHERN IDAHO FREIGHTLINES, INC.

II.

The term for which said corporation shall exist shall be in perpetuity.

III.

The location and address of the registered office of this corporation in the State of Idaho, shall be 255 6th Avenue North, Twin Falls, Idaho 83301. The registered agent shall be Robert W. Galley.

IV.

The objects and purposes for which this corporation is formed shall be and are:

To transport for hire all types of goods and commodities within the State of Idaho.

V.

The Board of Directors of this corporation shall have the power to repeal and amend the by-laws of this corporation, and shall have the power to adopt new by-laws; this power may be

exercised by the Board of Directors through a majority vote of that Board. By-laws so repealed, amended or adopted by the Board of Directors, subject to these articles and the by-laws of the corporation, shall be subject to reenactment, amendment or repeal by the shareholders of this corporation at their regular meeting or at any meeting specially called for that purpose. A two-thirds vote of the shareholders of the corporation may exercise the powers of reenactment, amendment or repeal heretofore set out. The by-laws of this corporation shall regulate the manner of voting for this and other governing actions of the corporation. The initial Board of Directors shall consist of two directors.

VI.

The amount of authorized stock of the corporation shall be one thousand (1,000) shares of common, voting stock at no par value. None of the stock shall be preferred and there will be one restriction on the shares. That restriction is the remaining shareholders have the right of first refusal to purchase any other shareholders stock then the corporation itself shall have the right of second refusal to purchase any other shareholders stock before it can be offered to the general public. The stock shall be sold at the fair market value. Shares of stock of this corporation shall be non-assessable.


