

ARTICLES OF INCORPORATION
FOR
POCATELLO TARGET AND SHOOTING SPORTS, INC.

ARTICLE I

PREFACE

We, the undersigned natural persons, of legal age and citizens of the United States of America and residents of the State of Idaho, acting as incorporators, hereby adopt the following as the Articles of Incorporation for Pocatello Target and Shooting Sports, Inc., pursuant to the provisions of the Idaho Nonprofit Corporation Act.

ARTICLE II

NONPROFIT PURPOSE

The Corporation is formed exclusively for purposes permitted by the provisions of Title 30, Chapter 3, of the Idaho Code, more particularly set out below. It will engage in no permitted activity requiring a license without first obtaining such a license and will conduct no activities that could be construed as conducting an insurance company under Idaho Insurance Laws. No dividends will be paid by the Corporation and no part of its income shall be distributed to its members or officers, except for reasonable compensation for services rendered. The Corporation will not engage in any conduct not permitted by a Corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code or any like future provision of such Code. Further, it shall not attempt to influence legislation by propaganda or otherwise, nor shall it intervene in, or participate in, any political campaign on behalf of any candidate for public office. Upon dissolution, none of the corporate property or its proceeds shall be distributed to or inure to the benefit of any of the members, but

shall be distributed to Corporations or other organizations qualifying for Federal income tax exemption under the aforesaid Section of the Internal Revenue Code.

ARTICLE III

DURATION

The period of duration of the Corporation shall be perpetual.

ARTICLE IV

PURPOSE

This Corporation is organized to plan, construct, organize, and maintain a safe facility for public shooting, and for any other purposes necessary or convenient to achieve these ends or permitted by Idaho law, including education for and encouragement of the safe handling of firearms and competitive shooting sports.

ARTICLE V

MEMBERSHIP

The management of the affairs of the Corporation shall be vested in its members in accordance with the provisions of Section 30-314(c) of the Idaho Code. Qualification and other membership details will be set out in the bylaws of the Corporation. Members shall not be personally liable for the debts, liabilities, or obligations of the Corporation.

ARTICLE VI

INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation will be in the office of William W. Becker, its initial registered agent, 508 Spaulding Building, 109 South Arthur Street, Pocatello, Idaho 83204. The initial Board of Directors, who shall serve until their successors are elected in accordance with the bylaws, shall consist of the incorporators, whose names and addresses are listed below.
