KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, a majority of whom are residents and freeholders of Idaho County, in the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of an Act of the Legislature of the State of Idaho, entitled "An Act Providing for the appointment of a State Bank Commissioner, prescribing his qualifications, duties and compensation; fixing the capital required to do a banking business, and providing for the examination, regulation and control of banks and banking business and fixing the fees for such examinations; providing for the formation and conduct of banking corporations and for the sale of delinquent stock thereof, and fixing the qualification and liability of officers, directors and stockholders of banks and banking corporations; prohibiting banking, except under the provisions of this act; providing for the liquidation of banks and the distribution of the assets thereof; making an appropriation for the carrying out the purposes of this act; declaring an emergency, prescribing penalties, and repealing other acts in conflict with this act." Approved on the 6th day of March, 1905, and the general incorporation laws of the State of Idaho, and all other laws of the State of Idaho, which are applicable:-

And we hereby Certify:-

- 1.- That the name of said corporation shall be DENVER STATE BANK.
- 2.- That the purposes for which it is formed are, to transact a general banking business, to receive deposits of money, and to pay interest on the same, to loan money, either upon personal property as security, or upon real estate, or otherwise; to buy and sell promissory notes, drafts, bills of exchange, and other evidences of debt, and any securities therefor; to write insurance; to act as financial agent for other corporations or persons; to acquire and hold real estate, and generally to perform any and all acts and things necessary or proper in the transaction of

a general banking business, consistent with the laws of the State of Idaho.

3.- That the place where the principal business of said corporation is to be transacted is in Denver, Idaho County, in the State of Idaho.

4.- That the term for which corporation is to exist is 50 (fifty) years from and after its incorporation.

5.- That the number of Directors of said corporation shall be seven and that the names and residences of the directors who are appointed for the first year are as follows, to-wit:-

6.- That the amount of the Capital stock of said corporation is \$20000.00 and the number of shares into which it is divided is 200 of the par value of \$100.00 each.
