KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, each being a natural person of full age and a citizen of the United States of America, hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation:

I.

The name of this Corporation shall be NELSON BROTHERS CUSTOM FARMING, INC..

II.

The term of existence of this corporation shall be perpetual.

III.

The location and registered office of this corporation shall be 1116 Maple Drive, Mountain Home, Idaho 83647, and the registered agent of the corporation shall be Vern F. Nelson at that address.

IV.

The authorized capital stock of this corporation shall be \$50,000.00, divided into 500 shares of the par value of \$100.00 each. All of the stock shall have the same powers and voting rights and shall be non-assessable.

v.

The purposes for which this corporation is organized shall include the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho, including but not limited to the following:

To engage in seed potato cutting and other custom farming operations.

VI.

The holder of any shares in this corporation may not transfer said share to any person other than the corporation or another holder of shares in this corporation without first offering to sell such shares to the corporation and if the corporation declines, within 30 days of such offer, to purchase such shares at the price offered by a non-stockholer, then the holder of the shares for sale must offer the same to the other holders of shares at the same price, and in proportion to the number of shares held by each. If such shareholders also decline to meet such offer of purchase, then the shares may be sold to any other qualified person, at a price not less than that offered to the corporation of the shareholders.

VII.

Three directors shall constitute the intitial board of directors. The names and addresses of the persons who are to serve as directors until the first annual meeting of stockholders, or until their successors be elected and qualified, are as follows:
