Dear Sir:

Pursuant to the authority vested in the General Tax Counsel by the Company's by-laws and with respect to the delegation of such authority by certain Resolutions adopted by the Executive Committee of Texaco Inc. on June 20, 1963 and ratified by the Board of Directors on June 28, 1963, as amended by the Resolution adopted by the Executive Committee on December 17, 1964, you are hereby authorized to execute on behalf of the Company all tax returns, reports, statements and other submissions required to be filed by the Company with the Governments of the following States of the United States and political subdivisions thereof, with respect to all types of taxes imposed by such governments, including, but without limitation, income, franchise, real and personal property, production, severance, capital stock, motor fuel, sales, use, mercantile, privilege, and business occupancy taxes:

Alaska	Hawaii	Oregon
Arizona	Idaho	Utah
California	Montana	Washington
Colorado	Nevada	Wyoming

The term "Company" means Texaco Inc. and its subsidiaries, including Getty Oil Company and its subsidiaries.

You are also hereby authorized to execute and file on behalf of the Company any and all claims for refund of such taxes in the aforementioned States and subdivisions or agencies thereof; and (except in the case of income and franchise taxes which is subject to approval of the General Tax Counsel) to prosecute, defend, compromise, or settle any administrative proceeding instituted by or against the Company in any matters having to do with the determination of such taxes, including authority to execute agreements with such governments and subdivisions and agencies thereof as to periods within which such taxes may be lawfully levied, assessed or collected.
