## ARTICLES OF AMENDMENT OF OF NORTHWESTERN AUTOMOTIVE, INC., as Talk Corporation

Pursuant to the provision of the Idaho Business Corporation Act, the undersigned hereby adopts the following Articles of Amendment of the Articles of Incorporation:

- 1. The name of the corporation is NORTHWESTERN AUTOMOTIVE, INC.
- 2. The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on the 3157 day of 0ec, 1982: Pwn

V

The shares of stock to be issued by this corporation shall consist of two classes, namely: (1) 10,000 shares of common stock having a par value of \$1.00 per share; and (2) 65,000 shares of preferred stock having a par value of \$1.00 per share. Said preferred stock shall have no voting rights and shall not be entitled to any dividends. However, said preferred stock shall have preference over the common stock of the corporation upon the voluntary or involuntary liquidation of the corporation, and is redeemable or payable upon liquidation at par value.

- 3. The number of shares outstanding at the time of such adoption was 10,000; the number of shares entitled to vote thereon was 10,000.
- 4. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows: All stock was of the same class.
- 5. The number of shares voted for such amendment was 10,000; and the number of shares voted against such amendment was  $\emptyset$ .
- 6. The number of shares of each class entitled to vote thereon as a class voted for and against such amendment, respectively, was: No stock was entitled to vote as a class.
- 7. The manner, if not set forth in such amendment, in which any exchange, reclassification or cancellation of

issued shares provided for in the amendment shall be effected, is as follows: No change.

8. The manner in which said amendment affects a change in the amount of stated capital, and the amount of stated capital is changed by such amendment, are as follows: The stated capital will increase to a total of \$75,000.00.
