(b) To invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and to own real or personal property necessary for the rendering of the professional service provided for above, all as authorized in Idaho Code §30-1307.

(c) To do and have any and all general powers as described and set forth in the Professional Service Corporation Act, Title 30, Chapter 13, Idaho Code.
