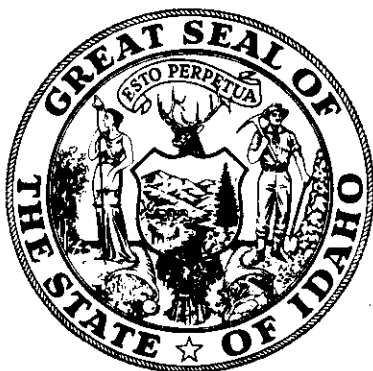

ARTICLES OF INCORPORATION

OF JUL 1 8 28 AM '81

DENNIS BROS. INC. STATE

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is DENNIS BROS. INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

1) To carry on the business of grain dealers, on its own account, and as commission merchants, track buyers and selling agents for the account of others; to buy, sell, import, export, trade and deal in grain in and cereals of all kinds and all cereal products, feed, meal, hay, straw, fodder, wood products, and agricultural products of all types and description, including livestock.

2) To own, operate, and maintain trucks and any other means of transportation of agricultural produce, wood products commodities or livestock and other property of every kind and nature.

3) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 500 shares of common stock, all of one class, with a par value of \$100.00 per share.

FIFTH: The address of the initial registered office of the corporation is Route #2-Box 205 A, Gooding, Idaho 83330, and the name of its initial registered agent at such address is KIPMAN A. DENNIS, Route #2-Box 205A, Gooding, Idaho 83330.
