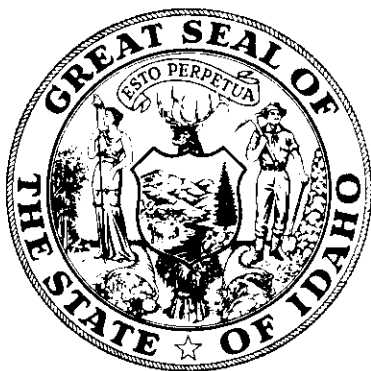

1 ARTICLES OF AMENDMENT  
2 TO THE  
3 ARTICLES OF INCORPORATION OF  
4 McCREA HEATING & PLUMBING, INC.

6 Pursuant to the provisions of Section 61 of the Idaho  
7 Business Corporation Act, the undersigned corporation adopts the  
8 following Articles of Amendment to its Articles of Incorporation:

9 FIRST: The name of the Corporation is McCREA HEATING &  
10 PLUMBING, INC.

11 SECOND: The following Amendment of the Articles of Incor-  
12 poration was adopted by the shareholders of the corporation on  
13 28th day of August, 1981, in the manner prescribed by the  
14 Idaho Business Corporation Act:

15 That ARTICLE FIRST of the Articles of Incorporation which  
16 originally reads as follows:

17 (a) "FIRST: The name of the corporation is McCREA HEATING  
18 & PLUMBING CO., INC.",  
19 is hereby amended to read as follows:

20 (b) "FIRST: The name of the corporation is McCREA HEATING  
21 & PLUMBING, INC."

22 THIRD: The number of shares of the corporation outstanding  
23 at the time of such adoption was 500; and the number of  
24 shares entitled to vote thereon was 500.

25 FOURTH: The number of shares voted for such amendment  
26 was 500, and the number of shares voted against such  
27 amendment was 0.
