

NAME

1. The name of the corporation is SORENSON INSURANCE, INC.

DURATION

2. The period of it's duration is perpetual.

PURPOSE

3. The purpose or purposes for which this corporation is formed are as follows:
 - (a) The purpose of SORENSON INSURANCE, INC. is to engage in the sale of business, property, home, auto, and life insurance, and all it's related activities, and/or the business of holding, owning, maintaining, managing, improving, developing, operating, selling, transferring, conveying, leasing, mortgaging, exchanging, or otherwise disposing of or dealing in or with real property, or dealing with or otherwise dealing in any other necessary, lawful, and proper business enterprise, under the designation, name and style of SORENSON INSURANCE, INC.; and to perform any acts to accomplish the foregoing purposes; and
 - (b) Except as otherwise prohibited by Idaho law, the corporation, in furtherance of it's corporate purposes set forth above, shall have all of the powers necessary and proper for the effectuation of any and all legitimate enterprises of the corporation, subject to any limitations provided by the laws of the State of Idaho.






