ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

being full age citizens of the United States,
That we, the undersigned, have this day voluntarily associated
ourselves together for the purpose of forming a corporation under
the laws of the State of Idaho, and to that end do hereby adopt
Articles of Incorporation as follows:

I.

The name of the proposed corporation is **ALLIED BUILDERS,**
INCORPORATED.

II.

The purposes of this corporation are to engage in the general
construction of buildings and to contract with others to build,
fabricate and erect structures of all sorts; to lease, purchase
or contract for the purchase of real property upon which to erect
said structures; to sell, lease or contract with others to purchase,
lease or contract to purchase said real property and the improvements
thereon; to sublease certain portions of general building contracts
to subcontractors; to subcontract with other general contractors to
erect certain structures or parts thereof; to furnish and equip
structures which they may erect; to remodel, rebuild or improve
existing structures; to make improvements other than buildings
to real property such as the erection of parking lots, waterways,
sidewalks and roadways and to do all other things generally and
commonly done by building contractors.

III.

The duration of this corporation shall be perpetual.

IV.

The location and post office address of the registered office





