**ARTICLES OF INCORPORATION**

The undersigned natural person being of legal age, acting as incorporator under the provisions of the Idaho General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation is DH Financial Services, INC

**ARTICLE II**

**PERIOD OF DURATION**

The duration of this corporation is to be perpetual.

**ARTICLE III**

**PURPOSES AND POWERS**

The purposes and the powers for which this corporation is organized are the performance of financial planning and investing services as provided by the laws of the State of Idaho.

**ARTICLE IV**  
**CAPITAL STOCK**

The aggregate number of shares, which the corporation shall have authority to issue, is a thousand (1,000) shares of common stock, all of one class without par value.

**ARTICLE V**  
**INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of the corporation is 680 S Woodruff Idaho Falls, ID 83401; The name of the initial registered agent at the office is Dave Hansen.

**ARTICLE VI**  
**DISTRIBUTIONS**

The shareholder of the corporation may, from time to time, distribute to themselves out of capital surplus of the corporation a portion of its assets, in cash or property, subject to the following provisions;

- (a) No such distribution shall be made at a time when the corporation is insolvent to when such distribution would render the corporation insolvent;
- (b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares;
- (c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the stockholder receiving the same concurrently with the distribution thereof.

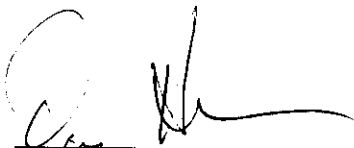

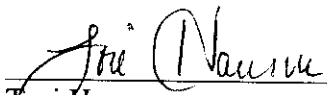

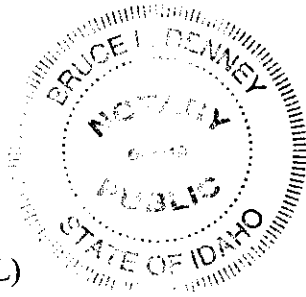
