## ARTICLES OF INCORPORATION 14 PM 3 52

The undersigned, acting as incorporator of BRYANT AND ASSOCIATES, INC., a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BRYANT AND ASSOCIATES, INC.

SECOND: The period of its duration is perpetual.
