THE UNDERSIGNED incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation.

ARTICLE ONE

 $\underline{\text{Name}}$. The name of the corporation is R & R OUTDOORS, INC.

ARTICLE TWO

<u>Purposes</u>. The purpose of the corporation is to engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.
