LEBRET, each being of full age and citizens of the United States, have associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and in pursuance thereof do hereby sign and acknowledge the following Articles of Incorporation in triplicate originals and do state as follows:

- a. To own, conduct, operate, maintain, and carry on the business of Cabaret, night club, tavern, and restaurant and to sell and dispense foods, beverages, and liquids of all kinds and to do any and all other things necessary and pertaining to said business;
- b. To do any and all things and acts and to exercise any and all other powers which a co-partnership, or natural person may do or exercise to the extent permitted by law to corporations under the laws of the State of Idaho.
