# ARTICLES OF INCORPORATION

of

IDAHO DAIRY COUNCIL, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all full age citizens of the United States, this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation without capital stock, under and pursuant to Title 30, Chapter 10 of the laws of the State of Idaho, and that we do hereby make, acknowledge and declare the following to be our Articles of Incorporation.

## ARTICLE I - NAME AND PLACE OF BUSINESS

The name of the Corporation shall be Idaho Dairy Council, Inc., and the principal place of business shall be in Boise, Ada County, Idaho, and at such other branch offices as may be designated by the Board of Directors.

## ARTICLE II - OBJECTIVE AND PURPOSE

The Corporation is organized for the purpose of contributing to the achievement of optimal health by Idaho citizens through leadership in nutrition research and nutrition education based on the concept of a balanced diet, including milk and milk products, in accordance with scientific recommendations, thus increasing the market for milk and dairy products, strengthening the dairy industry and Idaho Agriculture; and

To perform any operation and to conduct any affairs authorized or permitted by the Idaho Not-For-Profit Corporation Code and to

conduct and perform any and all activities that may be related in any manner to the foregoing.

Net earnings, properties or assets of this Corporation are irrevocably dedicated to educational, charitable and scientific purposes and, upon dissolution or otherwise, shall not insure to the benefit of any private person or individual or to any member or Director of this Corporation. Upon the liquidation or dissolution of the Corporation, all properties and assets of the Corporation remaining after paying or providing for all debts and obligations thereof shall be distributed and paid over exclusively for the purposes of the Corporation or to some other fund, foundation, organization or corporation organized exclusively for educational, charitable and scientific purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1954, as now in effect or as subsequently amended, as the Board of Directors of this Corporation shall determine.

### ARTICLE III - DURATION

The duration of this corporation shall be perpetual unless dissolved in accordance with the laws of the State of Idaho.

### ARTICLE IV - MEMBERSHIP

The Board of Directors of the corporation shall have the power to admit members to the corporation in such manner, subject to such qualifications, and upon such terms and conditions as the by-laws may specify; providing the rights of each new member are equal, and no member shall have or acquire a greater interest therein than any other member.

ARTICLE V - BOARD OF DIRECTORS

The affairs of the corporation shall be controlled and managed by a Board of Directors. The method of election of directors shall be determined by the by-laws of the corporation.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

ARTICLE VII - AMENDMENTS

These Articles of Incorporation may be amended by a two-thirds (2/3rds) vote of the entire membership of the corporation at any regular or duly called special meeting of the membership.

ARTICLE IX - PRIVATE PROPERTY EXEMPT

The private property of the members of this corporation shall be exempt from any and all liability for any debts or obligations of the corporation.
