ARTICLES OF INCORPORATION
OF
OVER THE EDGE, INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of Idaho Business Corporation Act, adopt the following Articles of Incorporation.

ARTICLE ONE - Name. The name of the corporation is **Over The Edge, Inc.**

ARTICLE TWO - Purposes. The purposes of the corporation are to assemble groups of people for the purpose of enjoying a high adventure including but not limited to bungee jumping, hot air balloon riding, white water rafting, hiking, camping, mountain climbing, repelling and to engage in any or all lawful businesses for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE - Duration. The period of duration of the corporation perpetual.

ARTICLE FOUR - Registered Office and Registered Agent. The Address of Corporation's initial registered office in the State of Idaho is 160 Parrish Drive, City of Chubbuck, County of Bannock, State of Idaho, Space 83202. The name of the corporation's initial registered agent at such address is Eric D. Lyman.

ARTICLE FIVE - Stock. The authorized number of par value share of common stock is Fifty Thousand (50,000) all of one class at One Hundred Dollars (\$100.00) par value per share.

ARTICLE SIX - Preemptive Rights. No preemptive rights shall exist.

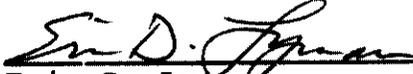

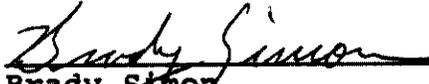
