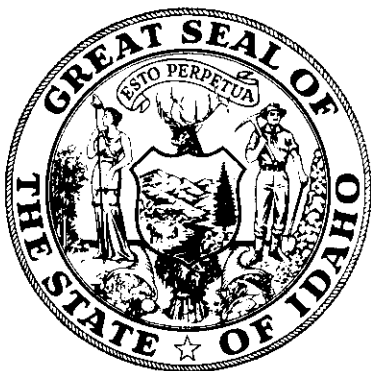

ARTICLE OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
HELMICK & SHADDUCK, INC.

Pursuant to the provisions of section 30-1-59 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is HELMICK & SHADDUCK, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on June 3, 1987, in the manner prescribed by the Idaho Business Corporation act.

ARTICLE I.

THIRD: The name of the corporation shall be ROBERT I. HELMICK, INC.

FOURTH: The number of shares of the corporation outstanding at the time of such adoption was 12,800; and the number of shares entitled to vote thereon 12,800.

FIFTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:
