

ARTICLES OF INCORPORATION (Non-Profit)

The undersigned, a majority of whom are citizens of the United States, in order to form a Non-Profit Corporation under the provisions of The Idaho Nonprofit Corporations Act, Title 30, Chapter 3, of the Idaho Statutes, submit the following articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be:

Idaho Youth at Risk Corporation

Article 2: The purposes for which the corporation is organized:

- (1) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (2) The specific purpose for which this corporation is organized is to provide the opportunity for at risk youth to alter the course of their future, through self-exploration, discovery and committed, passionate mentorship.
- (3) The purpose of this corporation is to engage in any lawful act or activity for which corporations may be organized under The Idaho Nonprofit Corporations Act, provided, however, that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(c)(3) tax-exempt purposes, which are described above.

Article 6: The mailing address of the corporation shall be:

Article 7: The corporation DOES NOT have voting members.

Article 8: The period of duration for this corporation is perpetual.

Article 9: Upon dissolution the assets shall be distributed:

Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision of payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 10: Limitation on Political Activities:

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Article 11: Limitations on Private Inurement:

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Article 12: General Limitations on Nonprofit Activities:

Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
