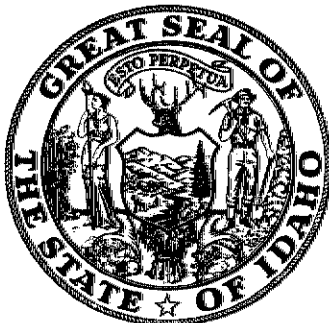

Construction, Inc.


B. Except for this designated amendment, the Articles of

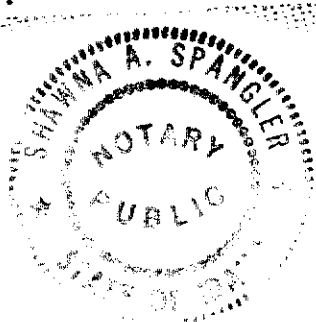


