ARTICLES OF INCORPORATION

OF

MAGIC CAR & TRUCK CO.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, RICHARD B. HILL, RAY McKINSTER, JR., and EDWARD L. BENOIT, each residents of the State of Idaho, and residing in the County of Twin Falls, Idaho, each and all citizens of the United States of America, of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end, do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

I.

That the name of said corporation is and shall be MAGIC CAR & TRUCK CO.

II.

That said corporation is formed for the following purposes:

a. To engage in the business of buying, selling, renting, leasing, and financing motor vehicles of all kinds and descriptions and all equipment, supplies and parts of all kinds and descriptions incidental thereto; and to deal in all kinds of merchandise generally used in connection with such business; to operate and maintain a repair and paint business of all types of motor vehicles.

b. To receive, acquire, hold, purchase, dispose of, convey, mortgage, and/or lease, real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote, sell,

pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign.

c. To conduct business in this state, other states, District of Columbia, territories and colonies of the United States and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situate out of this state.

d. To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department thereof.

e. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business.

f. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression, or declaration of specific or special powers or purposes herein enumerated shall

be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

III.

That the location and post office address of the registered office of the corporation shall be Jerome, Jerome County, State of Idaho.

IV.

That the duration and existence of this corporation is to be perpetual.

V.

That the amount of the authorized stock of said corporation shall be Two Hundred Fifty Thousand (\$250,000.00) Dollars, divided into Two Hundred Fifty Thousand (250,000) shares of common stock at the par value of One (\$1.00) Dollar each.
