**ARTICLES OF INCORPORATION
OF
QUANTUM INTERLINK INTERNET, INC.**

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is QUANTUM INTERLINK INTERNET, INC. Qi³ and qi³ shall be trademarks of QUANTUM INTERLINK INTERNET, INC.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are:

A. To provide corporations, electronic bulletin boards, government entities and subdivisions, individuals and other users access to the worldwide network of computer systems, known collectively as The Internet; and

B. To provide customers and users other related products and services such as publishing on-line, hyperdocuments, consulting and training services, varied advertising techniques, and other innovative technologies; and

C. To develop, patent, copyright or otherwise patent, protect and exploit new inventions, software, hardware, designs and systems related to computers, The Internet, and related technologies; and

D. And all other things incidental thereto necessary to conduct business together with transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is one million shares (1,000,000) of \$1.00 par value common stock. The corporation retains the authority to split stock as it deems necessary, contingent upon the majority vote of its board of directors.

FIFTH

Shareholders shall have full pre-emptive rights.

SIXTH

Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Idaho Code § 30-1-23A.

SEVENTH

The address of the initial registered office of the corporation is 285 N.W. Main, P.O. Box 1047, Blackfoot, Idaho, 83221, and the name of its initial registered agent at such address is Murray Jim Sorensen.

EIGHTH

The number of directors constituting the initial Board of Directors of the corporation is two, and the names and addresses of persons who are to serve as Directors until the first annual meeting

of shareholders, or until the first annual meeting of shareholders, or until their successors are elected and shall qualify are:
