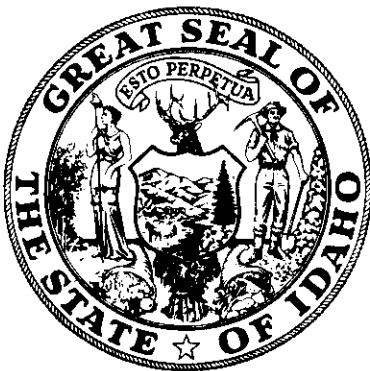

ARTICLES OF INCORPORATION

OF

KEN-SPRAY, INC.

SECRETARY OF STATE

The undersigned natural persons, hereby establish a professional service corporation pursuant to the statutes of Idaho, and adopt the following Articles of Incorporation:

I

The name of the Corporation is Ken-Spray, Inc.

II

The Corporation shall have perpetual existence.

III

The purpose or purposes for which the Corporation is organized are to conduct an aerial spraying application business and to own, lease buy, sell and charter for hire aircraft and to purchase, lease or otherwise deal with real property in conjunction with that business and to carry on any other activity in the interest of that business, which a corporation under the laws of the State of Idaho may so conduct.

IV

The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares having no par value.

V

The address of the initial registered office of the Corporation is Route 2, Twin Falls Airport, Twin Falls, Idaho 83301, and the name of its initial registered agent at such address is Kenneth L. Owings.




