

The Undersigned, acting as incorporators of corporation under the Idaho Business Corporation Act, adopt the following Articles of Amendment for such corporation.

 $\underline{FIRST}$ : The name of the corporation is HAWKER ENTERPRISES, INC.

SECOND: The Articles of Incorporation, filed with the Secretary of State on March 24th, 1995, be amended to provide that the aggregate number of shares which the corporation shall have authority to issue, is 3,000,000 shares, with a par value of \$1.00 per share.
