PLEASE BE NOTIFIED, that Weholt Park and Orchards, Inc., of HCR 67 Box 37, Grangeville, Idaho 83530, a corporation in good standing, that was originally incorporated on the 15th day of June, 1977, pursuant to the Consent of the shareholders, which is attached hereto and hereby incorporated by this reference, desires to dissolve its corporation and provides as follows:

The board of directors met in a special meeting and adopted a resolution directing that the corporation be dissolved. Furthermore, all of the shareholders were present at that meeting and they consented also to that dissolution. Thus, all of the shareholders have consented. Furthermore at that meeting all of the directors were present and voted to dissolve the corporation. Additionally the corporation shows as follows:

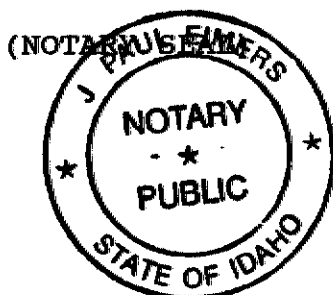

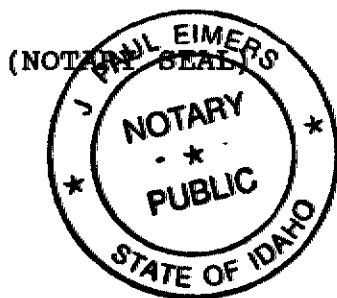
