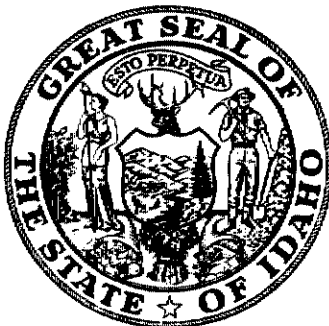

**ARTICLES OF INCORPORATION  
OF  
MONARCH MARKET, INC.**

The undersigned, acting as incorporators of a corporation ("Corporation") under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such Corporation.

**ARTICLE I. NAME**

The name of the Corporation shall be Monarch Market, Inc.

**ARTICLE II. PERIOD OF DURATION**

The period of existence and duration of the life of this Corporation shall be perpetual.

**ARTICLE III. PURPOSES**

This Corporation is organized for the purposes of operating a retail grocery store and market.

The Corporation is further organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**ARTICLE IV. STOCK**

The total authorized number of shares of stock in the Corporation shall consist of Two Hundred Thousand (200,000) shares of common stock. No par value will be attached to the stock. All shares shall be one class, denoted common stock. Each share is entitled to one (1) vote.
