## AMENDED ARTICLES OF INCORPORATION

OF

SHOSHONE COUNTY MINING AND SMELTING MUSEUM, INSECTIVE 1986, with Eunanimous approval, by a majority of the members present.

Article X has been amended to comply with a request by the Internal Revenue Service.

## ARTICLE X. (AS AMENDED)

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

This corporation shall be and remain a non-profit corporation, wherein pecuniary profit is not the object of the members of the corporation; it is organized and shall exist under the provisions of the Idaho Code, Section 30-301 to 30-322, both inclusive; no part of the earnings of this corporation shall inure to the benefit of any member or members but shall be devoted exclusively to the purposes of said corporation and to charitable, patriotic, civic and benevolent purposes.
