AMENDMENT OF THE ARTICLES OF INCORPORATION OF THE

HIGHLAND-SURPRISE CONSOLIDATED MINING COMPANY

KNOW ALL MEN BY THESE PRESENTS; That we, the undersigned the President and Secretary respectivelly of the HIGHLAND-SURPRISE CONSOLIDATED MINING COMPANY, do hereby cerdify as follows:

That the HIGHLAND-SURPRISE CONSOLIDATED MINING COMPANY is a corporation organized and existing under and by virtue of the laws of the State of Idaho.

Pursuant to call and notice, the stockholders of the Highland-Surprise Consolidated Mining Company convened in annual meeting at the office of the company in Wallace, Idaho on Monday Epril 14, 1955 at 10:00 a.m. Frank J. Luedke, the President called the meeting to order and acted as chairman and W. A. Callaway, the Secretary, acted as Secretary of the meeting.

There were present at said meeting stockholders holding more than two-thirds percent of the voting power of said corporation, that is 871,453 shares present out of the total outstanding shares in the amount of 1,168,860 shares, that were entitled to vote.

That the following is a full, true and correct copy of said consent of said shareholders to the amendment of the articles of incorporation:

- "WHERAS, this corporation was organized under the laws of the State of Idaho on the 24th day of August, 1912, and was incorporated for an existence of fifty (50) years; and
- "WHEREAS, the charter of this corporation will expire on the 24th day of August, 1962, and it is believed to be to the best interest of said corporation and the stockholders thereof that the existence of said corporation be extended, and that the existence of said corporation be perpetual.

"THEREFORE, BE IT RESOLVED, that the Article "Fourth" of the Articles of Incorporation be amended and the same hereby is amended to read as follows:

FOUR TH

"That the term for which this corporation shall exist shall be perpetual."

"BE IT FURTHER RESOLVED, that Articles of Amendment shall be prepared setting forth said amendment and the adoption thereof which shall be signed by the President and the Secretary of the corporation and that the same shall be delivered to the Secretary of State of the State of Idaho pursuant to the provisions of the Idaho Code."

Stockholder Adam J. Reinhart moved that the foregoing resolution be adopted, which was seconded by stockholder John W. Barmettler and upon the same being put to vote all the stockholders present, both in person and by proxy, voted in favor thereof and the chairman declared said motion carried and said resolution adopted.
