duly certified by the Recorder of Washington County, to be a true copy of the original articles on file in his office, was filed in this department on the 14th day of July A. D. One Thousand Nine Hundred and twenty-eight

and is duly recorded in Book A-20 of Domestic Corporations, Records of the State of Idaho, and that the said articles contain the statement of facts required by Section 4696 of Idaho Compiled Statutes, to-wit:

**FIRST**, The name of the Corporation as aforesaid; **SECOND**, The purpose for which it was formed; **THIRD**, The place where its principal business is to be transacted; **FOURTH**, The term for which it is to exist; **FIFTH**, The number of its directors or trustees; **SIXTH**, The amount of its capital stock and the number of shares into which it is divided; **SEVENTH**, The amount of its capital stock actually subscribed and by whom.

**AND I FURTHER CERTIFY**, That the persons executing the articles and their associates and successors are hereby constituted a body politic and corporate, by the name stated in the articles, for the term of fifty years.

ARTICLES OF INCORPORATION  
OF  
COMMERCIAL BUILDING COMPANY

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are bona fide residents of the state of Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho

AND WE DO HEREBY CERTIFY:

I

That the name of the corporation shall be "Commercial Building Company."

II

That the purposes for which this corporation is formed shall be:

1. To carry on a general mercantile business of handling, buying and selling gas, oils, grease, gasoline and other petroleum products and automobiles and automobile accessories including tires, both as retailers and wholesalers.
2. To build, lease, purchase, sell, own and operate retail gasoline stations and wholesale gasoline plants.
3. To build, lease, operate, buy, own and sell garages and to engage in a general automobile business and motor power and machinery business of all kinds.
4. To drill for gas, gasoline and other petroleum products and to purchase, sell, and hold stock in

corporations organized for such purpose or for any other purposes herein set forth.

5. To do everything necessary, suitable or convenient for the accomplishment of the purposes aforesaid or any one or more of the same or such as are incidental thereto.

### III

The place where its principal place of business is to be transacted is Weiser, Washington County, State of Idaho.

### IV

That the term for which it is to exist is fifty years from and after the date of its incorporation.

### V

That the number of Directors shall be three, and the names and residences of those appointed for the first year are : F. O. Johnston, C. F. Brent, and James Harris, all of whom reside at Weiser, Washington County, Idaho.

### VI

That the amount of capital stock of said corporation is Twenty Thousand Dollars (\$20,000.00), and the number of shares into which it is divided is two hundred, of the par value of One Hundred Dollars (\$100.00) each.

### VII

That the amount of capital stock which has actually been subscribed is Four Thousand Two Hundred Dollars, (\$4,200.00), which has been subscribed by the following persons:
