ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GEM FURNITURE COMPANY

That we, the undersigned, the President and Secretary respectively of GEM FURNITURE COMPANY, an Idaho corporation, do hereby certify as follows:

That GEM FURNITURE COMPANY is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho;
