FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the board adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Certificate of Incorporation of Peregrine Mining Corporation be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:
