## ARTICLES OF INCORPORATION

OF

HEIL LAND & LIVESTOCK, INC.

## KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Lawrence O. Heil, Larry C. Heil and LaVaun I. Heil, all residents of the State of Idaho, each and all citizens of the United States of America, and each and all of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

#### ARTICLE I.

That the name of said corporation is and shall be "HEIL LAND & LIVESTOCK, INC."

#### ARTICLE II.

That said corporation is formed for the following purposes;

a. To engage in a general livestock, dairy and ranching business, both on its own account and as agent; to agist, feed, range, graze, manage, herd, control, brand, care for, purchase, market, and sell, livestock of every kind, both on its own account and as agent for other persons or corporations; buy, lease, cultivate, manage, operate, and sell ranch properties and products therefrom both on its own account and as agent for other persons or corporations.

b. To purchase, raise, import, export and deal in cattle and livestock of all kinds and to carry on a general cattle, sheep, hog, poultry, or any other manner of livestock or animal or grazing business; purchasing or acquiring, and selling or otherwise disposing of stocks, supplies, equipment, accessories, appurtenances, products and by-products, of said business.

- c. To purchase, own, improve, equip, operate and manage farms and engage in any agricultural pursuit or undertaking.
- d. To engage, maintain and operate a meat processing plant or plants for slaughter, packing and packaging, and processing, in all ways of meat products and foodstuffs of all and every kind, type or name.
- e. To carry on the business of a general warehouseman particularly to carry, maintain and conduct and operate dry storage warehouses, bonded warehouses and common warehouses for the storage of merchandise, machinery, furniture, farm products and all other products and manufacturers and chattels and effects, of all kinds, both of foreign and domestic production and manufacture.
- f. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal properties; to dispose of, sell, lease, sign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of its own and of other corporations, domestic or foreign.

g. To conduct business in this state, other states,

District of Columbia, territories and colonies of the United

States and in foreign countries, and to have one or more offices

and places of business out of this state, and to acquire, receive,

hold, purchase, lease, mortgage, dispose of, and/or convey real

and personal property situate out of this state.

h. To enter into, make, perform and carry out contracts, of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department thereof.

i. To carry on any other lawful business whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the corporation or to enhance the value of its properties and to have and exercise all right, powers and privileges which are now or may hereafter be conferred by the State of Idaho upon corporations; to execute from time to time general or special powers of attorney to persons, firms, associations or corporations and to revoke same as and when the Board of Directors may determine; and to do any or all of the things herein set forth to the same extent as natural persons might or could do.

j. Any and all of the rights, powers, privileges or restrictions in these Articles of Incorporation granted and contained, conferred or imposed may be enlarged, amended, altered, changed in any manner and to any extent, or repealed by articles of amendment made, executed, authorized by the laws of the State of Idaho.

k. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient, or auxiliary to any of the objects hereinbefore enumerated, or calculated, directly or indirectly to promote the interest of the corporation and to carry on its purpose, or for the purpose of attaining or furthering in any of its businesses.

To lend money and negotiate loans; ; to draw, accept endorse, discount, sell and deliver bills of exchange, promissory notes, bonds, obligations, securities of any government or authority or company; to form, promote, subsidize and assist companies, firms, and partnerships of all kinds; to act as surety and guarantor in any and all types of engagements, including the power to execute, endorse and deliver contracts and to guarantee the prompt and faithful performance and payment of debts, notes, agreements, contracts and undertakings of any other person, firm, partnership or corporation; and including also the power to act as an accommodation co-maker or guarantor of obligations either as a primary or secondary obliger; to enter into any arrangements with any authorities, municipal, local or otherwise conducive to the company's objects or any of them, and to obtain from any such government or authority any rights, privileges and concessions which the company may think it desirable to obtain, and to carry out, exercise and comply with any such arrangement, right, privileges, and concessions. Generally to carry on and undertake any business, undertaking, transaction, or operation commonly carried on or calculated directly or indirectly to enhance the value of, or render profitable, any of the company's property or rights.

The several clauses contained in this statement of 1 purposes shall be construed, as both purposes and powers, and 2 the statements contained in each clause shall, except where other-8 wise expressed, be in no way limited or restricted by reference 4 to or inference from the terms of any other clause, but shall be 5 6 regarded as independent purposes and powers. 7 ARTICLE III. 8 That the location and post office address of the corporation shall be Star Route, Castleford, Twin Falls County, Idaho. 9 10 ARTICLE IV. That, subject to dissolution, in the manner provided by 11 law, the duration of this corporation shall be perpetual. 12 13 ARTICLE V. That the amount of the authorized stock of said corpora-14 tion shall be \$250,000, divided into 2,500 shares of common stock 15 16 of the par value of \$100 per share. 17 ARTICLE VI. The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatever, and the shares of the corporation shall not

be subject to assessment for the purpose of paying expenses, con-

ducting business, or paying debts of the corporation.

ARTICLE VIII.

The number of Directors of the corporation shall be as specified in the By-Laws, provided the number of directors of the corporation shall not be less than three. In case of any increase in the number of directors, the additional directors may be elected by the directors then in office, and the directors so elected shall hold office until the next annual meeting of the stockholders and until their successors are elected and qualified.

All the officers of the corporation shall be stockholders, except that the secretary-treasurer may, but need not be stockholders, and any two or more offices may be held by the same one person. The term of office of the officers, except as in these articles otherwise expressly provided, shall be for one year and until their successors shall have beeen elected and qualified, unless sooner removed or resigned, as herein provided.

ARTICLE IX.

A majority of the board of directors shall constitute a quorum and shall have power to transact the business and exercise the corporate powers of the corporation and, except as otherwise provided herein, may mortgage, pledge, sell or otherwise dispose of real or personal property of the corporation for the purpose of carrying on the business of the corporation. board of directors shall have power to appoint agents and servants of the corporation, prescribe their duties and remove them at

LAW OFFICES HEPWORTH NUNGESTER pleasure and may fix the compensation of the officers, agents and servants of the corporation, and shall have power to vote and grant to themselves (and any officer or director may join in granting to himself such salary), commission or compensation for their services as officer or directors, or both as they may determine. The board of directors or the stockholders may, by a majority vote, adopt by-laws for the regulation of the affairs of the corporation, and by a majority vote amend or repeal the same, provided that such by-laws shall not conflict with these articles of incorporation. The by-laws adopted by the directors shall provide the time and place of directors' meetings and the manner of calling the same, which meetings may be held within or without the State of Idaho.
