KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, RICHARD H. WAITE, CAROL ANN WAITE and MARILYN JEAN WAITE, all of Hagerman, County of Gooding, State of Idaho, each and all citizens of the United States of America, of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

I

That the name of said corporation is and shall be
"233 BUS COMPANY, INC."

II

That said corporation is formed for the following purposes:

(a) To engage in the general busing and transportation business and to do all things connected therewith and incidental thereto.

(b) To exercise all authority and to perform all acts authorized under the provisions of Section 30-114 of the Idaho Code.
