

ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, And we hereby certify, first:

That the name of said corporation is the Twin Falls Manufacturing Company, Ltd.,

Second: That the purposes for which it is formed are, to purchase, lease or otherwise acquire lands and buildings in the city of Twin Falls, State of Idaho, or elsewhere, for the erection and establishment of a manufactory and work shops, with suitable plant and machinery, with a view to manufacture, purchase, sell, or otherwise deal in machinery designed for grubbing sage brush, and to manufacture, sell, or otherwise deal in farming implements of any and all kinds, to repair machinery and farming implements of all kinds, and in general to conduct a general blacksmith, manufacturing and repair business; and to sell, lease, or otherwise deal with real and personal property of the Company.

Third: That the place where the principal business is to be transacted shall be the city of Twin Falls, County of Cassia, State of Idaho.

Fourth: That the term for which it is to exist is fifty years from and after the date of this incorporation. ^{Fifth:} That the number of its directors shall be five and the names and residences of those appointed for the first year are,





