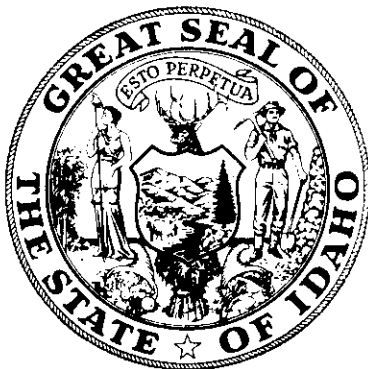

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, being a natural person of full age and a citizen of the United States, has this day voluntarily formed a private professional corporation under the laws of the State of Idaho, and to that end hereby adopts Articles of Incorporation as follows:

ARTICLE I

The name of this corporation is:

ARTICLE II


