We, the undersigned, a majority of whom are bonafide residents of the state of Idaho, so hereby voluntarily associate ourselves together for the purpose of forming a Corporation in the following form and manner, to-wit:

#### FIRST --

The name of the said Corporation shall be " THE WHITE CROSS MINING COMPANY, Limited"

#### SECOND --

The purpose for which said corporation is formed is to do a general mining business, and more especially the mining of Gold; to buy, sell, lease and locate mining claims, and to develope and operate the same; to hold and dispose of mining property, both real and personal; to buy, lease and hold, sell and dispose of tunnel rights, mill sites, quartz mills, reduction works, and all other machinery and tools and fixtures necessary for the operating of mines and the reduction of ores; to acquire water rights toed or to be used for mining and milling purposes, and to do all things proper to be done by such Corporation in the premises.

#### THIRD--

The place where the principal business of said Corporation shall be done is Moscow, Idaho.

# FCURTH--

The duration of said corporation shall be for a period of Fifty Years from the date hereof.
