For the purpose of forming a corporation under the provisions of the Idaho Code, Title 30, Chapter 3, known as the Idaho Nonprofit Corporation Act, the following Articles of Incorporation are adopted:

# ARTICLE I

The name of the corporation shall be: "Southern Idaho Romance Writers of America, Inc.".

# ARTICLE II

Southern Idaho Romance Writers of America is a nonprofit corporation.

#### ARTICLE III

The term of existence of this corporation shall be perpetual.

# ARTICLE IV

The purposes for which the corporation is organized are as follows: To raise and maintain a level of high quality romance writing, to act as a dissemination point for information, to secure respect for, interest in, and appreciation for the art of writing. To establish ethical standards and improvement in romance writing and to bring together authors, editors, agents and other related professionals for the mutual benefit of all.

# ARTICLE V

The name of the registered agent of the corporation is Robin Lee Hatcher. The registered office address, which is also the address of the registered agent, 2125 Mohican Place, Boise, Idaho 83709.

# ARTICLE VI

There shall be three directors serving as the initial Board of Directors. Their names and addresses are as follows:
