RESTATED ARTICLES OF INCORPORATION OF
CAMAS PRAIRIE INSURANCE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CAMAS PRAIRIE
INSURANCE, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including but not limited to sales of insurance or annuities of any kind, nature or type.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1000 shares of one class of common stock. The par value of said stock shall be \$1,000.00 per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation shall be governed by By-Laws adopted by the corporation.




