#### NATURE OF BUSINESS

The nature of the business and the object, purpose and powers of this Corporation shall be as follows:

- (a) To conduct, carry out and perform all activities relating to the selling and marketing of fuels and oils and convenience stores and all commodities and groceries therein marketed; and
- (b) To have, exercise, use and employ the authority specified in Section 30-1-4, <u>Idaho</u>

  <u>Code</u>, and to have, exercise, use, and employ any or all of the same, and any or all of the objects, purposes, powers, privileges, authority and rights therein and herein set forth, both within and without the State of Idaho and the United States of America; and to have one or more corporate or business offices, and to have and operate one or more agencies or other places of business within or without the United States of America.

#### CAPITAL STOCK

That the total authorized number of no par value shares of this Corporation shall be 600 shares each of no par value, which said shares shall be common stock and shall not be subject to assessment. The stock in this Corporation shall be restricted and shall be sold only to the other shareholders, and no outsiders shall be entitled to inherit, purchase or in any way own interest in the stock. Such restriction shall be noted on the stock certificate.
