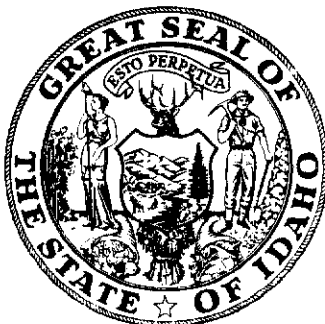

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, being the President of CASCADE RAFTING COMPANY, INC , an Idaho corporation, and following the adoption of a Corporate Resolution under and pursuant to the provisions of the general corporation laws of the State of Idaho, including the Idaho Business Corporation Act, and the acts amendatory thereof and supplemental thereto, does hereby amend the articles of incorporation of CASCADE RAFTING COMPANY, INC ., an Idaho corporation as follows:

1. NAME. The name of the corporation is CASCADE RAFTING COMPANY, INC.

2. AMENDMENT TO ARTICLES. ARTICLE I of the Articles of Incorporation of CASCADE RAFTING COMPANY, INC is hereby amended to change the name of the Corporation to CASCADE RECREATION COMPANY, INC., as follows:

The name of the Corporation is CASCADE RECREATION COMPANY, INC

3. DATE OF ADOPTION. The above referenced amendment was adopted by resolution of the shareholders of the corporation effective the 29th day of December 1994. At the time of the resolution there were 61,000 shares of stock outstanding and entitled to vote on the issue. Of the shares eligible to vote on the issue 6,500 shares were not represented either personally or through proxy at the meeting and the remaining shares (54,500) voted either personally or through proxy for the resolution.

4. EXCHANGE, RECLASSIFICATION OR CANCELLATION OF ISSUED SHARES The above referenced amendment does no provide for ~~exchange~~ reclassification or cancellation of issued shares of the corporation.
