We, the undersigned, do certify as follows:

1. The name of the Limited Partnership is "Sanders Farms", which is hereinafter referred to as "the Partnership".

2. (a) The character of the business of the Partnership is the acquisition, farming and exploitation of certain real and personal property located within and/or without the State of Idaho.

(b) Any person dealing with the Partnership or its properties shall be entitled to rely fully on any deed, mortgage, bill of sale, contract, note or other written instrument signed by all the General Partners, in the name and/or on behalf of the Partnership.

3. The principal place of business of the Partnership in the State of Idaho is Cassia County, Idaho. The Partnership may have such other offices in or out of the State of Idaho as the General Partners may determine.

(a) The amount of the cash contributed to the Partnership and a description, as well as the value of property contributed to the Partnership, by each Limited Partner and the share of the net profits or other compensation by way of income which each Limited Partner shall receive by reason of this contribution is as follows:

8. Rights to assign a Limited Partnership interest are subject to rights of first refusal held by the Partnership and the Partners.

9. Additional Partners can be admitted to the Partnership with the written consent of the General Partners and with payment for their Partnership units.



10. The remaining General Partners have the right to reconstitute the Partnership, form a new Partnership, and continue the Partnership's business upon the termination of the Partnership.


