We, the undersigned, W. L. Jungert, Chairman of the Board, and Marlene Jungert Secretary-Treasurer, of COMMUNITY METHODIST CHURCH OF COTTONWOOD, IDAHO, INC., an Idaho Corporation do hereby certify:

That the foregoing and herein Amended Articles of Incorporation of the Community Methodist Church in Cottonwood, Idaho, Inc., is a full, true and correct copy of the Articles of Amendment of said Corporation, as to name only, as amended by the members thereof on September 17, 1981.

That said corporation was incorporated under the laws of the State of Idaho, by certificate of Incorporation dated January 19, 1953, under the name of Community Methodist Church of Cottonwood, Idaho, Inc.

That on September 17, 1981, the active members and officers of said corporation by their unanimous written consent, which written consent is hereinafter contained, changed the name of said corporation from Community Methodist Church of Cottonwood, Idaho, Inc., to Community Church of Cottonwood, Idaho, Inc., and amended Article Number 1 of the original Articles of Incorporation of said corporation, which articles were filed with the Secretary of State of the State of Idaho on January 19, 1953, and recorded on film number 78 of said office, to read as follows:
