That the principal place of business shall be in the town of Rathdrum (whose Court name is Kootenai) County of Kootenai, aforesaid

That the term of existence shall be Twenty Years from and after the date of its incorporation.

That the Number of its Trustees shall be three, and that the names of those who shall be trustees and serve as such officers for the first three months and until the election of, and qualification of their successors are
