ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a CORPORATION, under the laws of the United States and of the State of Idaho, and we hereby certify:

ARTICLE I.

That the name of said corporation is the TYSON CREEK PLACER COMPANY, LIMITED.

ARTICLE II.

That the purpose for which it is formed is to CARRY ON THE BUSINESS OF MINING FOR GOLD AND OTHER MINERALS in the State of Idaho, and own, BUY AND SELL STOCK IN OTHER CORPORATIONS; TO BUY? OWN, CONSTRUCT AND SELL WATER DITCHES AND FLUMES AND CONDEMN RIGHT-OF-WAY FOR SAME.

ARTICLE III.

That the place where its principal business is to be transacted, shall be the City of Lewiston, County of Nez Perce, State of Idaho.

ARTICLE IV.

That the term for which it is to exist is Fifty (50) years from and after the date of its incorporation.
