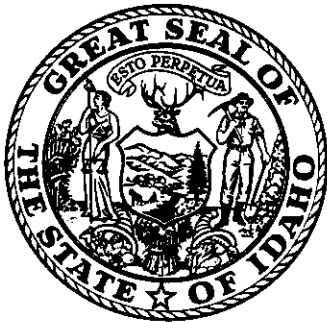

Dear Ms. Foust:

Your correspondence requesting approval of the corporate name "Merrick Bank Corporation" for use in the state of Idaho was received by facsimile on January 7, 2005, and has been reviewed by Department staff. Your letter represents that Merrick Bank Corporation is an industrial bank incorporated in the state of Utah, and is an FDIC insured deposit institution. Your letter also represents that the company will limit its activities in Idaho to making installment loans on boats and RVs through established dealers in the state of Idaho, and will not operate as a bank.

Please be sure that Merrick Bank Corporation has properly qualified under the Idaho Credit Code, Idaho Code § 28-41-101, *et seq.* prior to engaging in any lending activities that fall under that Act.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirement of the law. Rather, the Department is offering "no objection" to your company's use in Idaho of the name Merrick Bank Corporation. Under the circumstances set forth in your letter, we do not believe the name proposed by your company for use in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
