### ARTICLES OF INCORPORATION

OF

### QUALITY MOTORS, INC.

KNOW ALL MEN BY THESE PRESENTS: that we, the undersigned, being natural citizens of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general laws of the State of Idaho, do hereby certify as follows:

### ARTICLE I.

The name of the corporation shall be "QUALITY MOTORS,"

### ARTICLE II.

The corporation's purposes are:

- (a) To acquire, hold, operate, ane engage in the garage, body and fender, and automobile sales and service businesses, both new and used, and to engage in any business whatsoever as principal, agent, or partner which the corporation may deem convenient in furtherance of any of the purposes hereinabove mentioned, or otherwise, and to do any and all acts in the line of its business which it may deem necessary, profitable or desirable for the due promotion thereof, to conduct and carry on any other similar business which may be capable of being profitably carried on in connection with this company's business, or to carry on any similar business that is adapted directly or indirectly to add to the value of the company's property and the profits of its authorized business.
- (b) The corporation shall have the right to buy and hold personal property and such real estate as may be necessary for the proper conduct of the affairs of the corporation.
- (c) To engage in any commercial or industrial enterprise calculated or designated to be profitable to this corporation and in conformity with the laws of the State of Idaho.
- (d) To generally engage in, do and perform any enterprise act or vocation that a natural person might or could do or perform.
- (e) To have and exercise all rights and powers from time to time granted to a corporation by law.

### ARTICLE III.

The corporation is to have perpetual existence.

#### ARTICLE IV.

The location and post office address of the corporation's office in this state shall be Salmon, Lemhi County, Idaho

#### ARTICLE V.

The governing body of the corporation shall be a board of directors, and the number of directors on said board shall be that specified in the By-Laws, but shall in no event be less than three.

#### ARTICLE VI.

The board of directors of this corporation may meet and transact the business of this corporation either at the principal place of business herein designated or at such other place within or without the State of Idaho as may be designated by resolution of the board of directors.

## ARTICLE VII.

The amount of the authorized capital stock of this corporation shall be \$50,000, divided into 500 shares of the par value of \$100 per share. The said capital stock shall be non assessable.
