ARTICLES OF INCORPORATION

ARTICLE I

The name of the Corporation is Lube-It, Inc.

ARTICLE II PURPOSE

The purpose for which the Corporation is organized is to transact all lawful business for which corporations may be organized under the laws of the State of Idaho. The principal purpose of the Corporation is to provide motor vehicle repair maintenance and service to the general public.

ARTICLE III POWERS OF THE CORPORATION

As needed to pursue the corporate purposes, the Board of Directors shall have and may exercise all lawful powers necessary or convenient to effect the corporate purpose.

ARTICLE IV SHARES

The total authorized stock is: 10,000 common shares of no par value.

ARTICLE V

ARTICLE VII

The term of existence of the Corporation shall be perpetual.

ARTICLE VIII
INDEMNIFICATION OF DIRECTORS, OFFICERS,
EMPLOYEES AND AGENTS

The Corporation shall indemnify to the full extent permitted by law any person who has made, or threatened to be made, a party to any action, suit, or proceeding (whether civil, criminal, administrative or investigative) by reason of the fact that he, his testator or intestate is or was a Director, Officer, employee or agent of the Corporation or serves or served any other enterprise at the request of the Corporation.

The Corporation shall have power to purchase and maintain insurance on behalf of any person who is or was, a Director, Officer, employee, or agent of the Corporation, or is or was serving at the request of the Corporation as a Director, Officer,

employee or agent of another Corporation, partnership, joint venture, trust or other enterprise against any liability asserted against him and incurred by him in any such capacity or arising out of the status as such, whether or not the Corporation would have the power to indemnify him against such liability under the provisions of this section.

ARTICLE IX SPECIAL PROVISION FOR CLOSE CORPORATION

The Corporation is a close Corporation; no shares and no securities evidencing the right to acquire shares shall be issued by means of public offering, solicitation or advertisement. All issued shares, excluding treasury shares and all issued securities evidencing the right to acquire shares of the Corporation shall be held of record by no more than five persons in the aggregate.
